### **Event Overview**

Kenya ICT Action Network (KICTAnet) is a non-profit organization, a network and a multi-stakeholder platform for individuals and institutions interested and involved in ICT policy and regulation. KICTAnet is a catalyst for reform in the ICT sector and supports the national aim of ICT enabled growth and development.

Facebook is an American online social media and social networking service company. As of January 2018, Facebook had more than 2.2 billion monthly active users across the world. Facebook employs 25,000 people, and also owns and runs services such as Facebook, Instagram, Messenger, WhatsApp, Oculus VR, and Watch. In 2017, the company had a revenue of \$40.6 billion and a net income of \$15.9 billion.

Facebook has in the recent past come under intense scrutiny over the privacy of user information on its services. In addition, there has been debate and calls for action, over the use of its services to influence public discourse e.g. around elections, or through fake news and hate speech that can easily be spread through its platforms. The meeting is expected to facilitate open discussion surrounding these issues, and their impact in Kenya, with a view to developing a common understanding and joint strategies moving forward.
